The above purchaser has been provided with a shot and worming record and feeding and care instruction.

The above purchaser agrees NOT to spay (female pup), any earlier than 2 years of age or neuter (male pup) any earlier than 2 years of age, to allow for maturity and help prevent Orthopedic Disorders and other long term health problems associated with early spay/neuter.

The above-described puppy is guaranteed for 72 hours against contractible diseases. As long as no stops were made on the way home and the puppy was not let out to potty anywhere outside of the car. If above described puppy is found to be ill within the first 72 hours from taking possession, with a contractible disease, the purchaser must return the puppy to the breeder for a full refund or replacement and the puppy will be treated by the breeder's Veterinarian, or if purchaser chooses to keep the above described puppy, any and all Veterinary cost, associated with this condition, will be paid by the breeder up to the amount puppy was purchased for. Any Veterinary cost above the amount puppy was purchased for, will be the purchaser's responsibility. All Veterinary reports of diagnosis and receipts will be required. Purchaser must prove the puppy that is ill is the puppy identified with the above Micro Chip #. Identification test must be in writing by Veterinarian. This guarantee does not apply to puppies that have been injured or neglected. This guarantee only applies during the first 72 hours from the time purchaser took possession of the puppy and breeder must be notified within 15 days from taking possession. Purchaser is responsible for all cost of transportation, postal fees, and identification tests.

The seller guarantees puppy replacement for all hereditary defects known within the Labrador Retriever breed, for 24 months of age, of the above-described dog. This guarantee does not apply to cosmetic defects or allergies.

If purchaser, at any time or circumstance, is unable to keep above-described dog, purchaser agrees to return above-described dog to the seller. Cost for transportation will be the responsibility of the purchaser. No refund will be given. _____

24 MONTH HEREDITARY DEFECT GUARANTEE

Purchaser must prove the dog with a hereditary defect is the dog identified with the above Micro Chip # and must bring documentation to the breeder. The purchaser is responsible for the cost of all identification tests.

The above dog must be positively diagnosed with the defect and proven to be hereditary within the Labrador Retriever breed and verified in writing with references to the defect by a licensed Veterinary and/or through the OFA (Orthopedic Foundation for Animals), when applying to Hips and Elbows. Purchaser must verify this with written documentation from a licensed Veterinarian within 30 days of diagnosis.

The above dog must be at a level of mild, moderate, or severe hip dysplasia and bilateral or grade I, II or III elbow dysplasia and bilateral to qualify for guarantee. Purchaser is responsible for all diagnostic costs, including transportation.

This guarantee applies only for 24 months of age, of the above-described dog and has a positive diagnosis of hip or elbow dysplasia through the OFA or any other hereditary defect known within the Labrador Retriever breed, has not been used for breeding, has not been spayed (female), or neutered (male) prior to 24 months, and is not to be considered overweight by a licensed Veterinarian.

Breeder, Lexus Mason has the option to seek a second opinion on diagnosis (by exam if necessary) by any desired Licensed Veterinarian. Veterinary cost accrued for second opinion diagnosis will be the responsibility of the Breeder. _____

This guarantee does not apply to cosmetic defects such as miss-marked coats, overshot jaw, undershot jaw, wry mouth, missing teeth, allergies, or any other defect not causing debilitating conditions.

The above identified dog must be neutered/spayed if proven to have any hereditary defect known within the Labrador Retriever breed and verification of spay/neuter must be provided to the breeder by a licensed Veterinarian within 1 year of the positive diagnoses, or at 24 months of age. The responsibility of all cost, including transportation to be that of the purchaser.

If the above-described dog is positively diagnosed with a hereditary defect known within the Labrador Retriever breed, documentation has been provided and all terms and conditions are met, Purchaser has the option of a full refund of the purchase price including sales tax OR another AKC puppy as soon as one becomes available, which will have a written guarantee. Color and sex of replacement puppy is not guaranteed. Puppy replacement must take place within 1 years (12 months) from the date of above dog's diagnosis.

This guarantee does not apply to dogs that have been injured, abused, neglected, obese, spayed or neutered earlier than signed agreement states, or proper feeding and care instruction have not been followed.

Veterinary costs accrued are the responsibility of the purchaser. _____

This guarantee will be void if any part of agreement is broken or above-described dog is transferred to new ownership. _____

The above-described dog can remain with the purchaser and cared for accordingly or surrendered back to the breeder.
